INVITATION TO BID FOR THE PROCUREMENT OF 1 LOT VARIOUS DRUGS AND MEDICINES FOR THE MONTH OF DECEMBER CY 2023

1. The *BUREAU OF JAIL MANAGEMENT AND PENOLOGY – Regional Office VI* through the General Appropriation Act of Fiscal Year 2023 intends to apply the sum of *THREE MILLION SIX HUNDRED TWELVE THOUSAND FOUR HUNDRED THIRTY-SEVEN PESOS (Php 3,612,437.00)* being the ABC to payments under the contract for *Procurement of Drugs and Medicines for the Month of December CY 2023 with contract I.D. Nos; G6-012-23*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *BUREAU OF JAIL MANAGEMENT AND PENOLOGY – Regional Office VI* now invites bids for the above Procurement Project. This shall include, but not limited to the: 2.1 Rules and Procedure of Procurement; 2.2 Fixed Price Rule in Procurement; 2.3 Extension of the bid Validity and Security; 2.4 Validity of requirement prior to the award of the Contract; 2.5 Conditions of Award; and 2.5 Date of earliest delivery.

Delivery of the Goods is required ***within ten (10) Calendar Days upon receipt of the Notice to Proceed***. Bidders should have completed, within **TWO (2) YEARS** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from *BUREAU OF JAIL MANAGEMENT AND PENOLOGY – Regional Office VI* and inspect the Bidding Documents at the address given below during *office hours from 8:00 A.M. to 5:00 P.M.*
5. A complete set of Bidding Documents may be acquired by interested Bidders on July 24, 2023 to August 14, 2023 from the given address below

BUREAU OF JAIL MANAGEMENT AND PENOLOGY –Regional Office VI Ignie’s Place Building, Brgy Buhang, Jaro, Iloilo City and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees if it will be presented in person, by facsimile, or through electronic means.

6. The *BUREAU OF JAIL MANAGEMENT AND PENOLOGY – Regional Office VI* will hold a Pre-Bid Conference on **August 1, 2023 at 10:00 A.M.** at *BJMP- Regional Office VI Conference Room Ignie’s Place Building, Brgy Buhang, Jaro, Iloilo City* and/or through video conferencing or webcasting through *ZOOM application technology to be used*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, before **2:45 P.M August 14, 2023.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **3:00 P.M. August 14, 2023** at the given address below *BUREAU OF JAIL MANAGEMENT AND PENOLOGY – Regional Office VI Conference Room Ignie’s Place Building, Brgy Buhang, Jaro, Iloilo City*. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity or through Zoom Video Conferencing.
10. The *BUREAU OF JAIL MANAGEMENT AND PENOLOGY – Regional Office VI* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders
